# CALIBRATION TIPS + RESOURCES FOR YOUR CUSTOMERS

As harvest approaches, be sure to provide your customers with calibration resources and tips for them to have a smooth claims and harvest reporting experience. Farmers should ensure they update their software and monitors before they calibrate, as well as calibrating as crop conditions change.

Producers must calibrate within 3% accuracy at least once per year, per crop to meet the RMA calibration requirement to use precision production data for a crop insurance claim.
