Now you can join acreages and production features in the FMHA mapping system using the new Join icon. This feature makes typical production reporting processes simpler and faster.

Entity Reports Access

You don't have to leave the Mapping system to access entity reports anymore. You can now directly access the entity reports screen from within the mapping application during production reporting and sales season this winter.

Policy Sync

The Policy Sync feature now updates with each checked box, so you don't need to manually sync so often. The Policy Sync green indicator shows that a feature has been synced in the features information window. It also includes the new date and time stamp for confirmation.
