

COVID-19 Acknowledgement & Waiver

In consideration of my voluntary attendance and participation in the event and its associated activities (collectively, the "Event"), I understand that I am being asked to carefully read and agree to each of the following paragraphs:

On Wednesday, March 11, 2020, the World Health Organization (WHO) declared the novel coronavirus (COVID-19) outbreak a "global pandemic." COVID-19 infections have been confirmed throughout the world, including in the Event location. I acknowledge that I understand the risks of travel and Event participation, which may involve health risks associated with an outbreak of the COVID-19.

Assumption of Risks:

I understand that attending the Event in its very nature, will include certain inherent risks that cannot be eliminated regardless of the care taken, which may include risks associated with COVID-19.

By signing this agreement, I acknowledge and voluntarily assume the risk that I may be exposed an infectious or communicable disease such as COVID-19, or any variant thereof COVID-19, or any variant thereof, by attending the Event and that such exposure or infection may result in personal injury, illness, permanent disability and death.

I understand and appreciate that I may be exposed to health risks, dangers and hazards that are not under the direct control of the Sponsor associated with this travel.

I agree that my attendance and participation is voluntary and that I knowingly assume all such risks. I further agree that I am ultimately responsible for taking preventative measures for my own safety. I understand that the CDC continues to recommend that unvaccinated people take precautions to protect their health, such as wearing a mask, maintaining social distancing, and washing their hands.

I understand and will comply with onsite screening protocols that will be in place upon my arrival at the Event and agree that I will immediately notify the Sponsor if I: (i) experience symptoms of COVID-19, including, without limitation, fever, cough or shortness of breath, or (ii) have a suspected, diagnosed, of an infectious or communicable disease such as COVID-19, or any variant thereof, before arriving at the Event.

Release and Waiver:

I agree, for myself, my heirs, born or unborn, personal representatives or assigns, to hereby release, waive, discharge and covenant not to sue Famers Mutual Hail, employees, volunteers, agents, representatives, attorneys, affiliates and subsidiaries, their successors and assigns from and for any liability resulting from any injury or illness, however caused, arising from, or in any way related to, my attendance at the Event.

Hold Harmless, Indemnity and Release:

I agree, for myself, my heirs, personal representatives or assigns, to defend, hold harmless, indemnify and release, Famers Mutual Hail, employees, agents, attorneys, affiliates and subsidiaries, their successors and assigns from and against any and all

claims, demands, actions, or causes of action of any sort on account of personal injury to myself or any heirs, born or unborn, which may result from my participation in the Event. This release includes claims based on the negligence of Sponsor and its officers, employees, agents, representatives, and volunteers, but expressly does not include claims based on their intentional misconduct or gross negligence.
